



Agreement about cooperation between NRHA Norway, NRHA.DK and NRHA.fi Nordics Affiliates Agreement"

1. Purpose

The purpose of the agreement is to regulate the individual's relationship with Nordic Affiliates, including rights and obligations in the cooperation. This agreement is a formalization of the oral agreement between 2015 between the parts.

2. Parts

Agreement on participation in the Nordic Affiliate Partnership has been concluded between NRHA Norway, NRHA.DK and NRHA.fi

This agreement does not prevent the parties to the cooperation of the Nordic Affiliates from making or entering into separate agreements. The Nordic Affiliates Agreement has no effect on such agreements unless specifically stated.

3. Part Information

An overview of which parties are currently a member of the Nordic Affiliates Partnership and the description of the parties' social responsibilities and roles can be found on the respective affiliates' website.

The same website provides an overview of what data and services are available in the Nordic Affiliates Agreement. Information about all parties' contacts and other contact information is posted on these websites. The parties to this agreement undertake to make known this agreement to its members by publishing this document on its respective web pages.

4. Contract documents and rankings

Upon signing this Agreement, the parts accept the rights and obligations as set out in the General Terms and Conditions.

1. General Terms and Conditions

Members can start in NRHA Norway, NRHA.DK and NRHA Finland classes with the membership they have in their home country affiliate.

Year End Awards and LTE

Members who win money in these classes are credited with the Year End Awards in the Open, Non Pro, Rookie and Youth categories. If a rider is a member of two or more affiliates, he is entitled to participate in the Year End Awards in the affiliates he is a member of.

Earned money in all affiliates the rider is a member of must be rewarded in the Year End Awards rankings.

Money won in NRHA Norway, NRHA.dk and NRHA Finland classes applies to lifetime earnings in the respective affiliate's ranking.

Reporting

The Year End Awards period is from 01.01 to 31.12 each year. The parties to this agreement undertake to report earned money for those riders who are members of two or more affiliates by 15 January each year. Each Affiliate is required to keep up to date and to have an overview of which of its members is also a member of one or more affiliates.

5. Entry into force and duration

The agreement enters into force on 1 January 2018 and expires until terminated by one or more of the parties

6. Signature

The agreement is signed in 3- three copies, one for each of the parties
